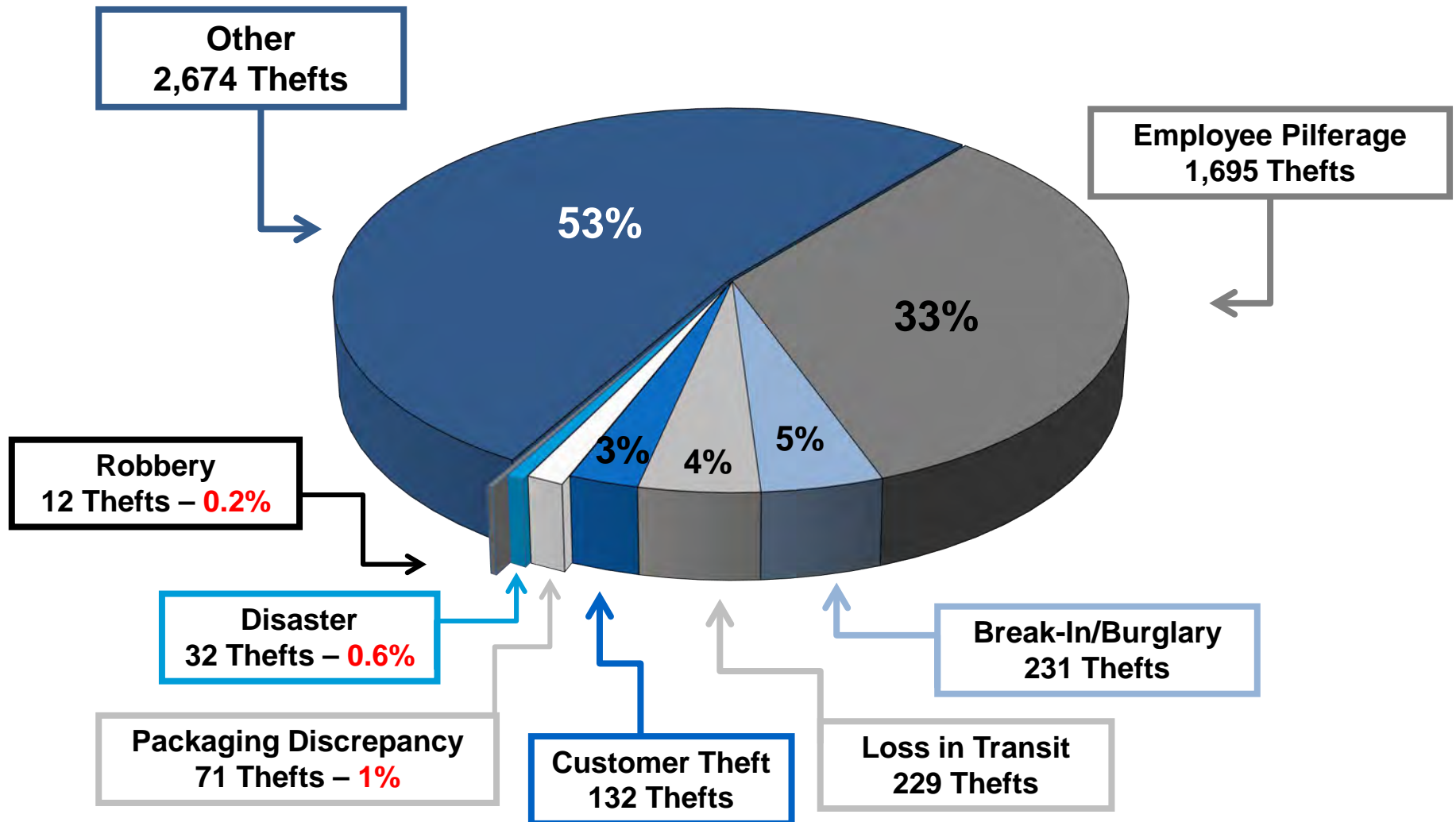


Top 5 Drugs Nationwide

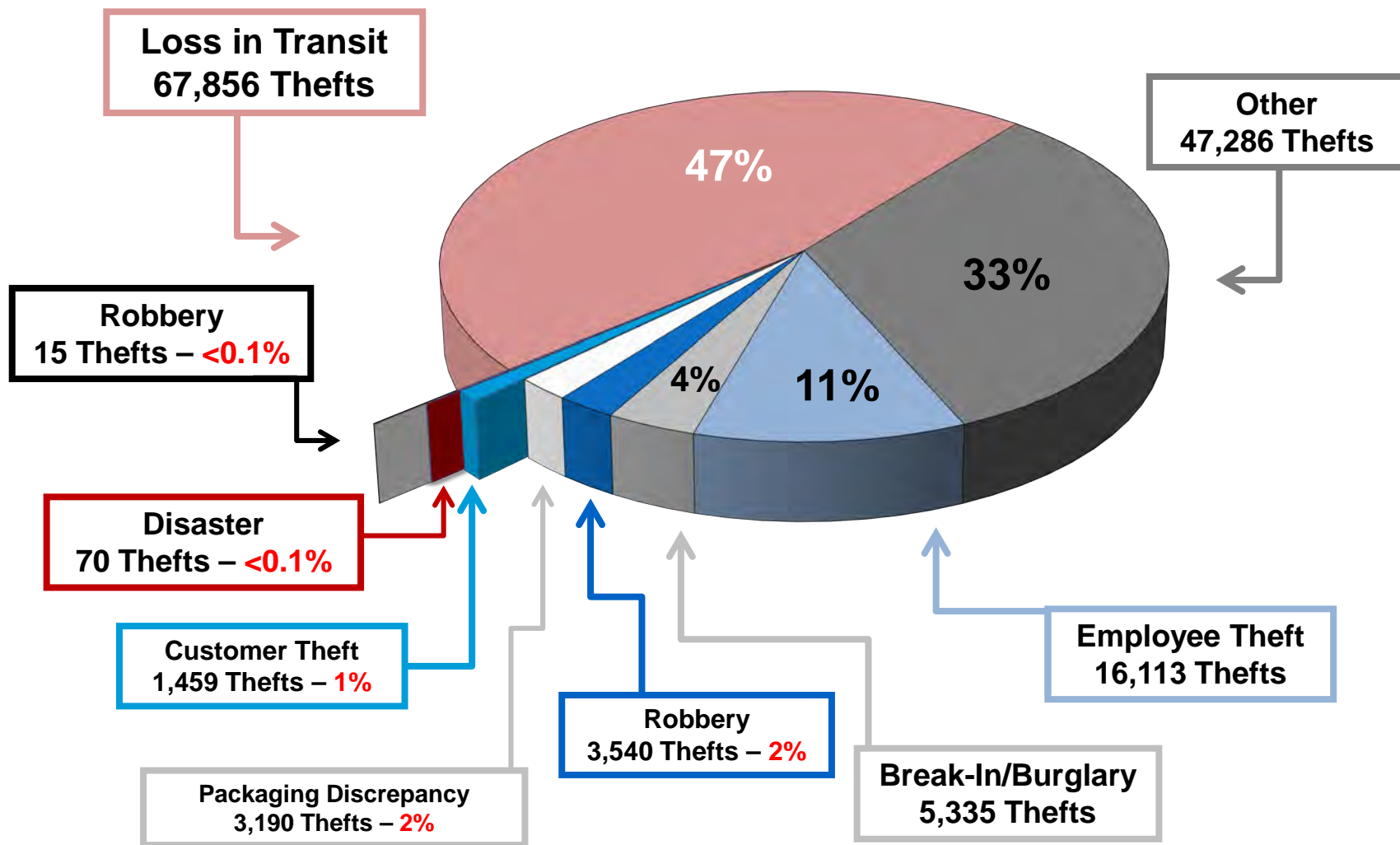

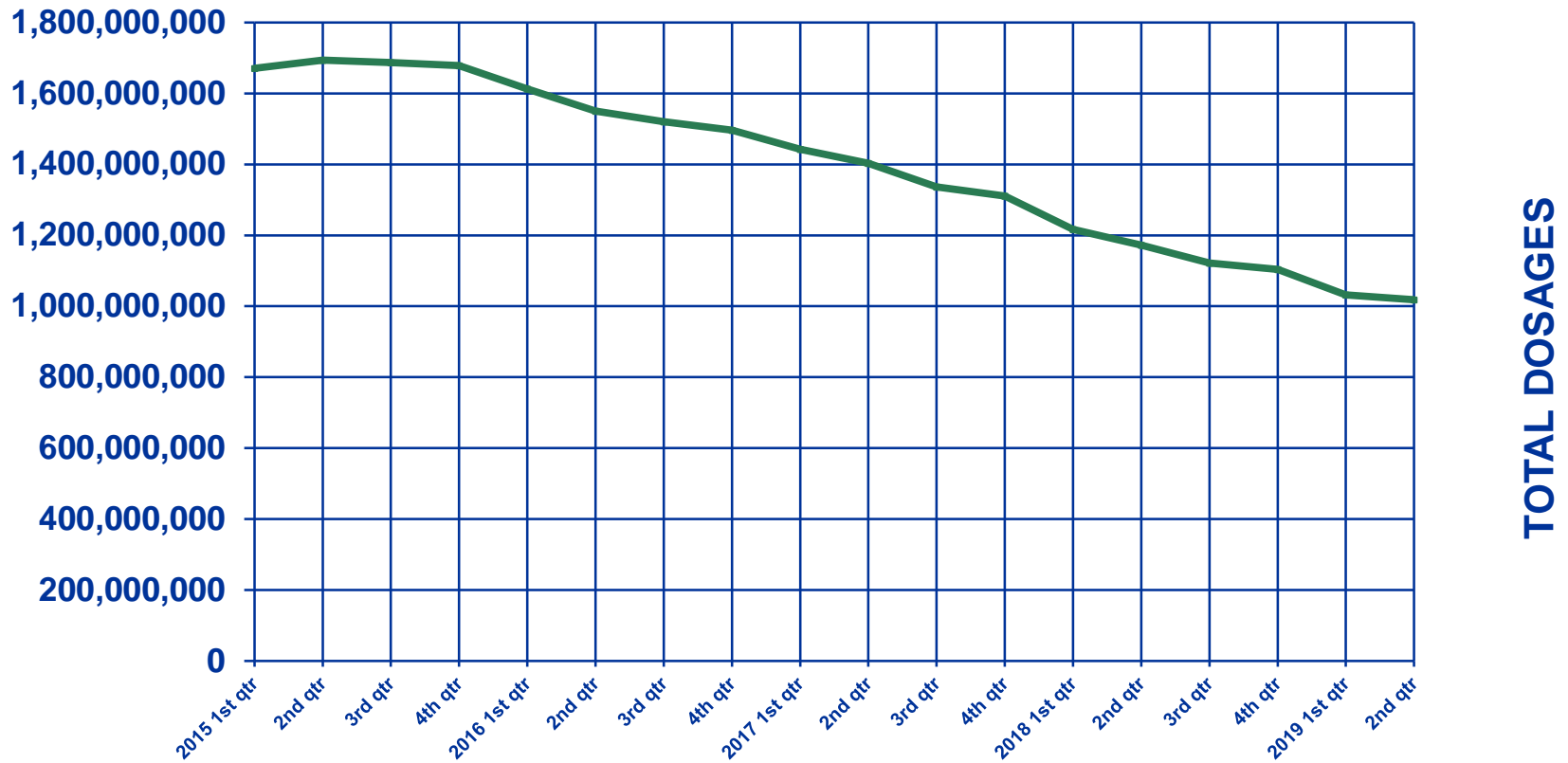

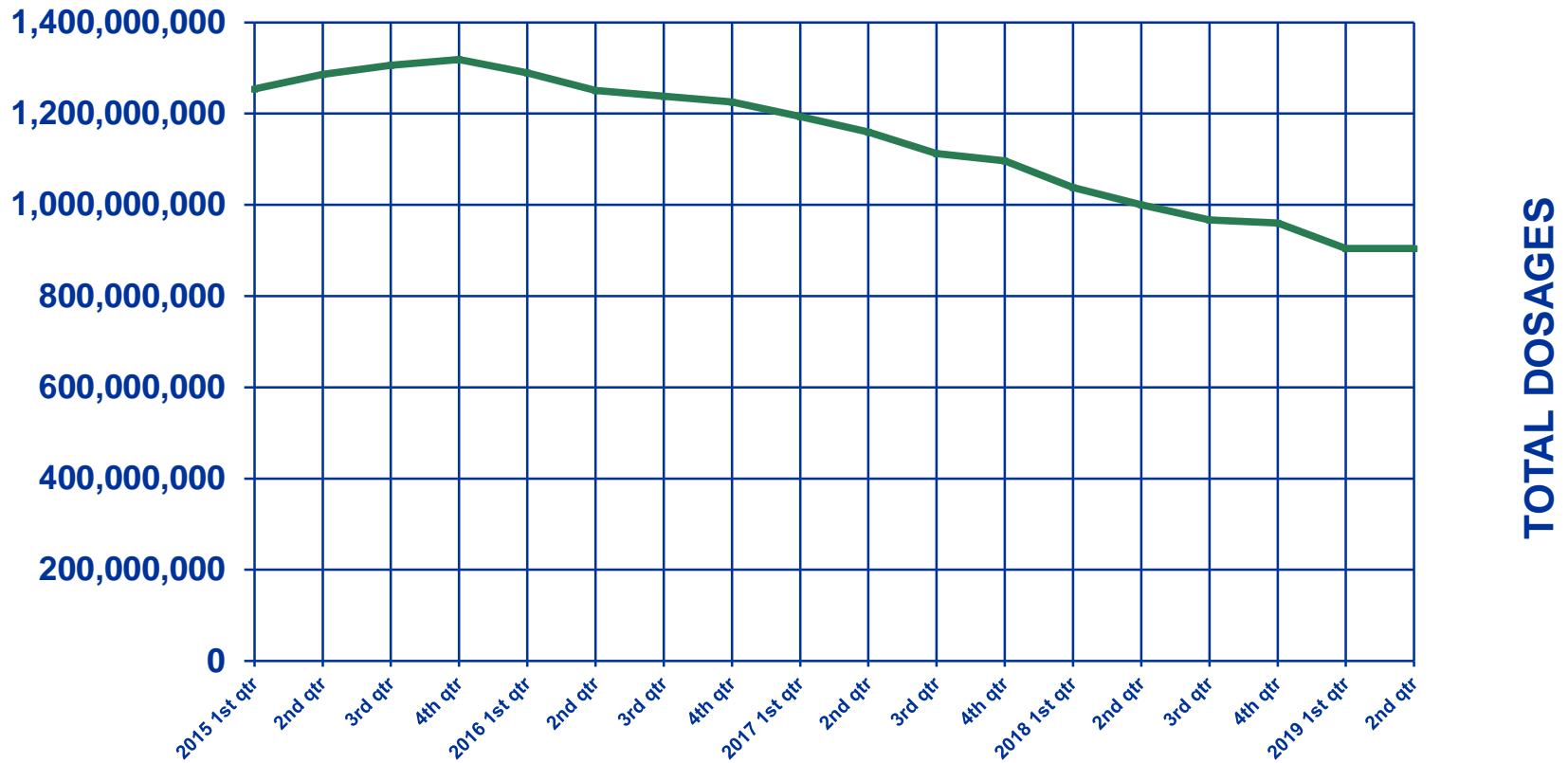

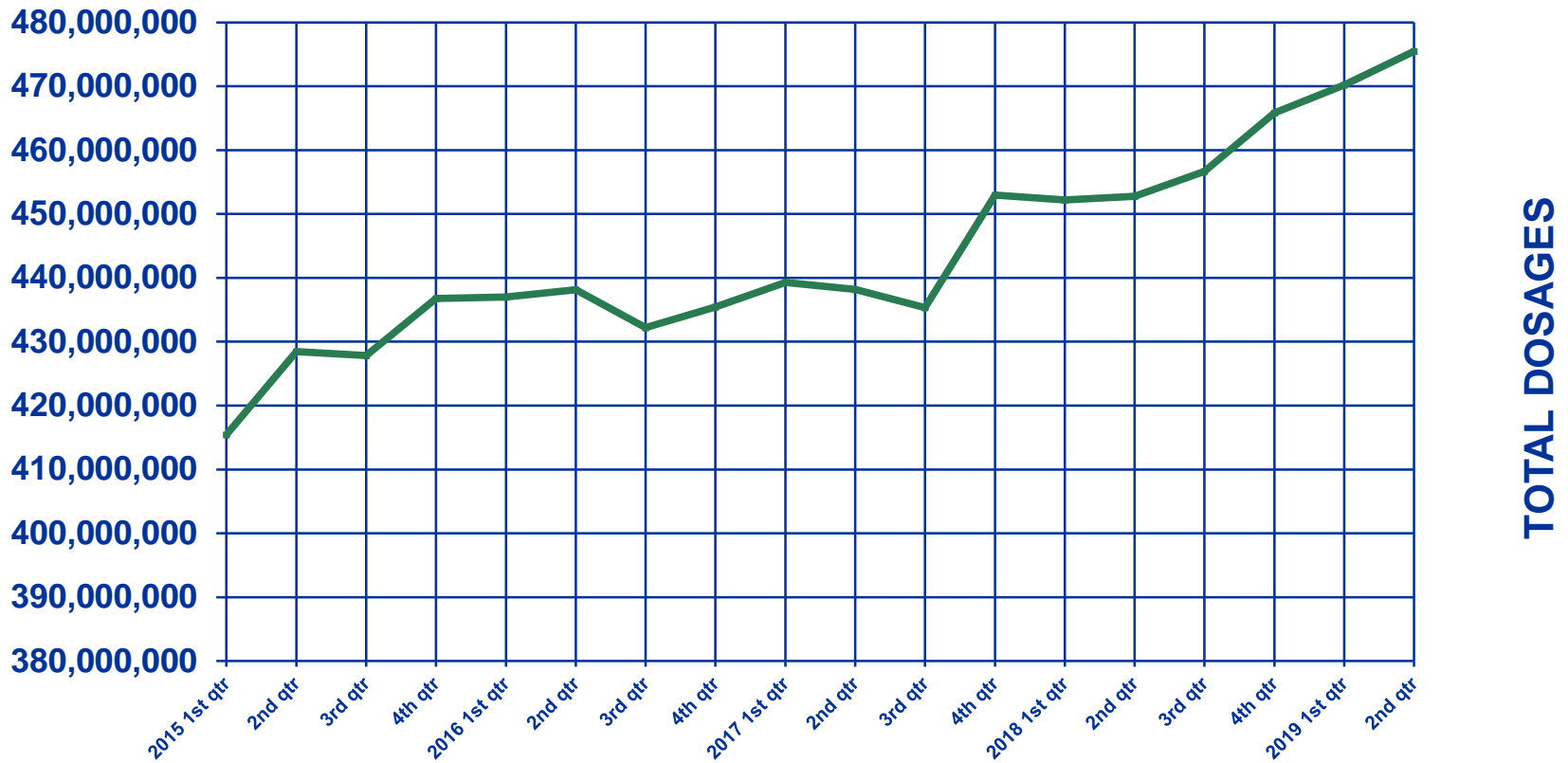
Nationwide Hydrocodone Distribution January 1, 2015 – June 30, 2019



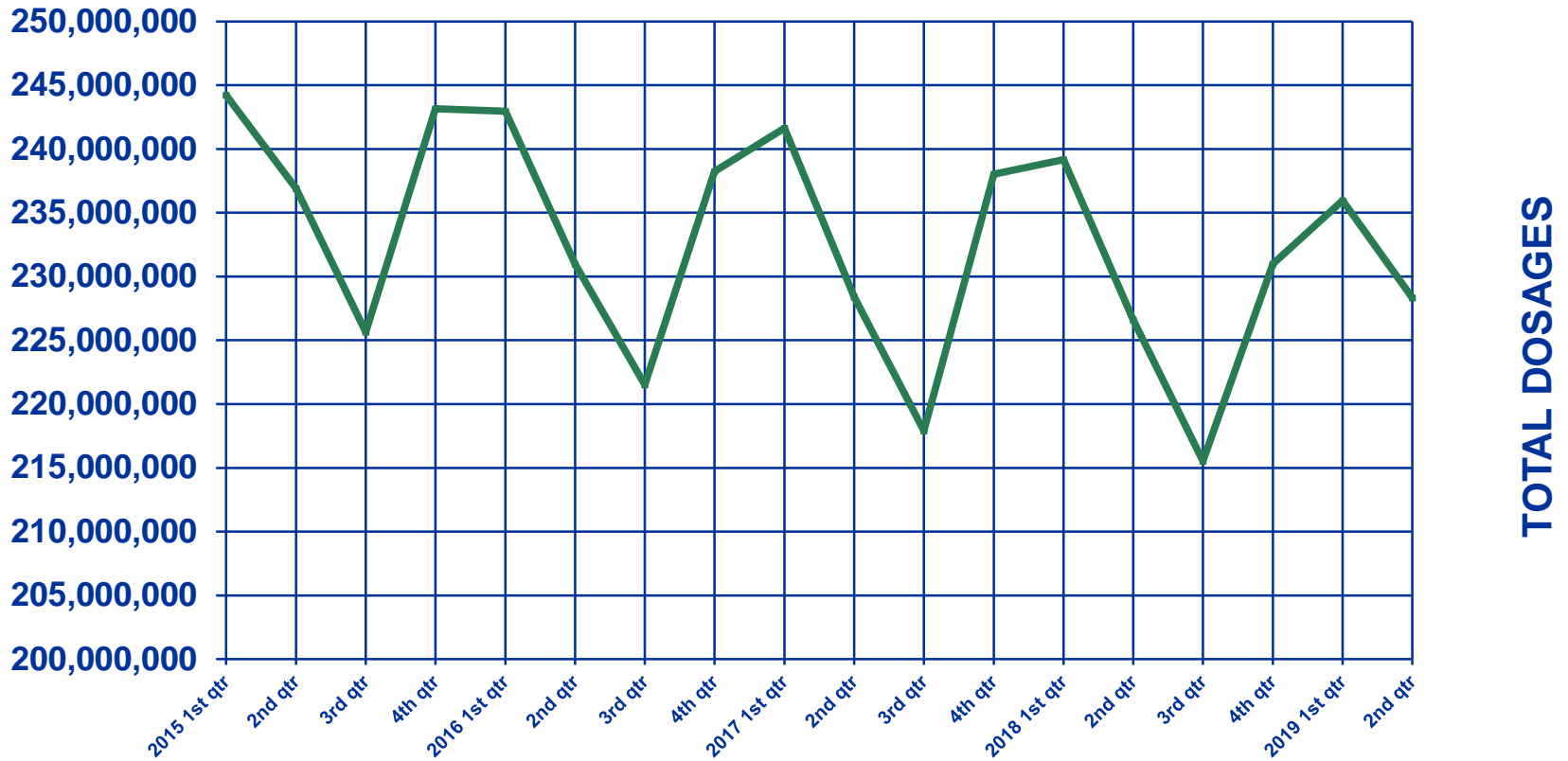
Nationwide Oxycodone Distribution January 1, 2015 – June 30, 2019



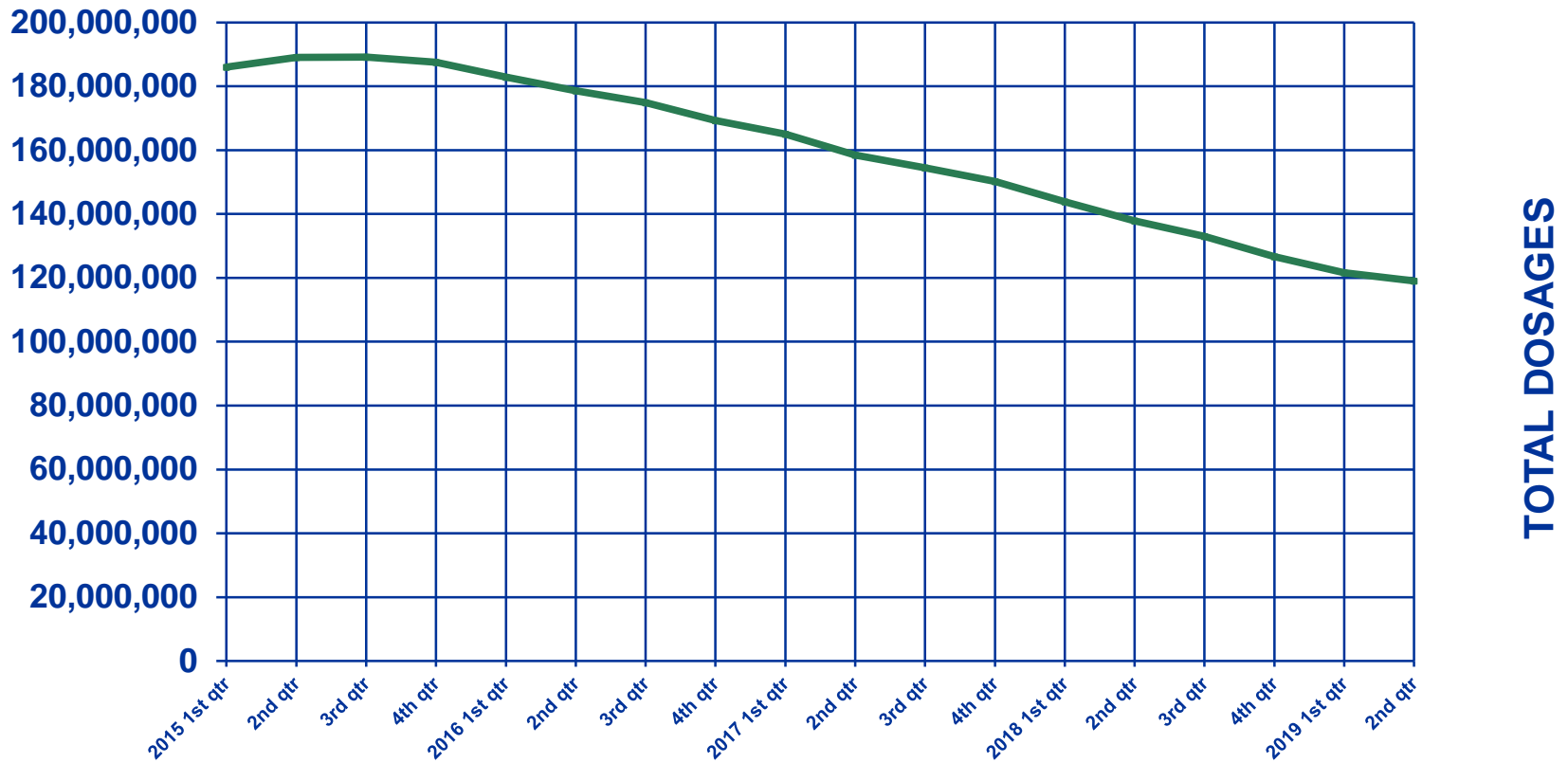
Nationwide Amphetamines Distribution January 1, 2015 – June 30, 2019



Nationwide Methylphenidate Distribution January 1, 2015 – June 30, 2019

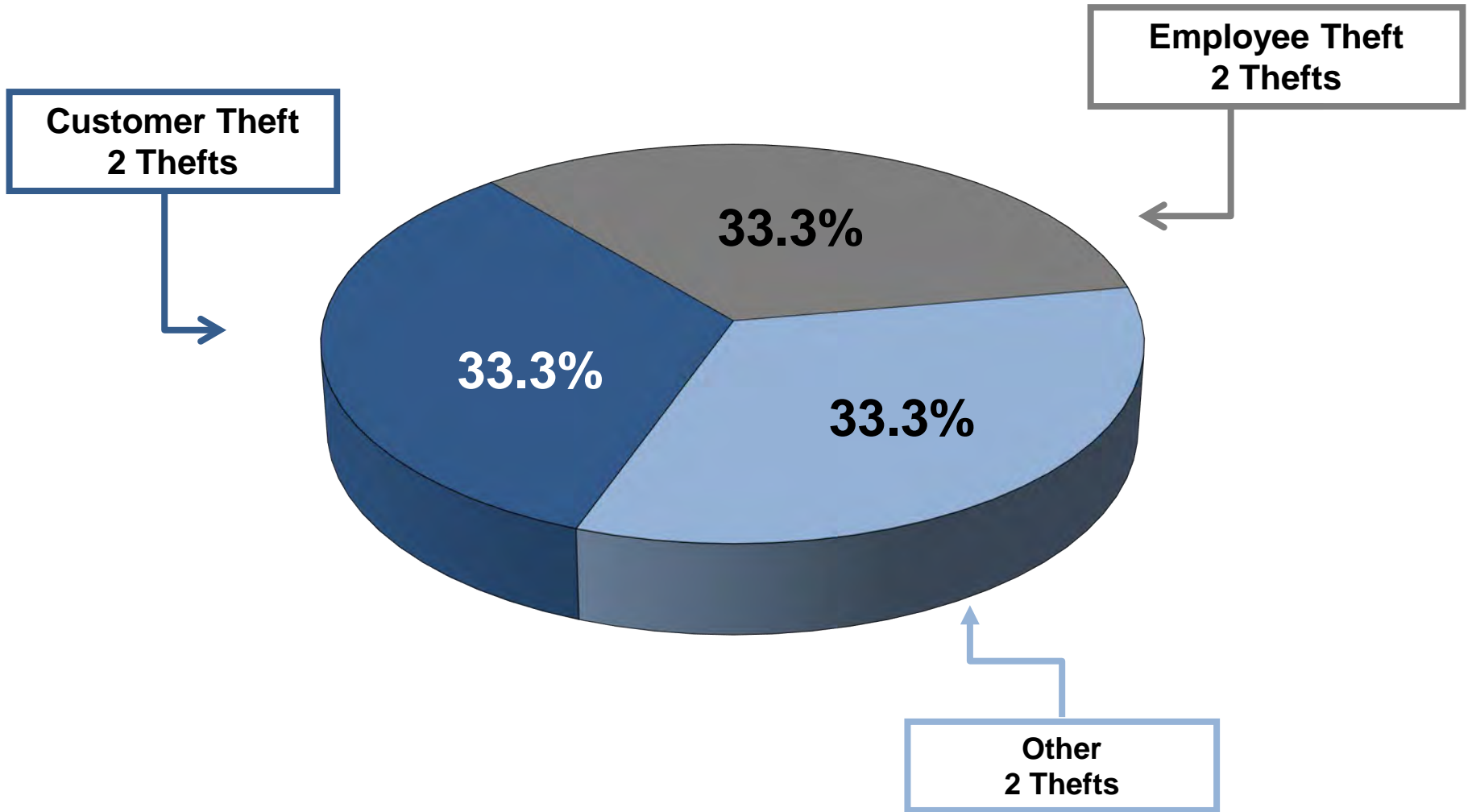


Nationwide Morphine Distribution January 1, 2015 – June 30, 2019

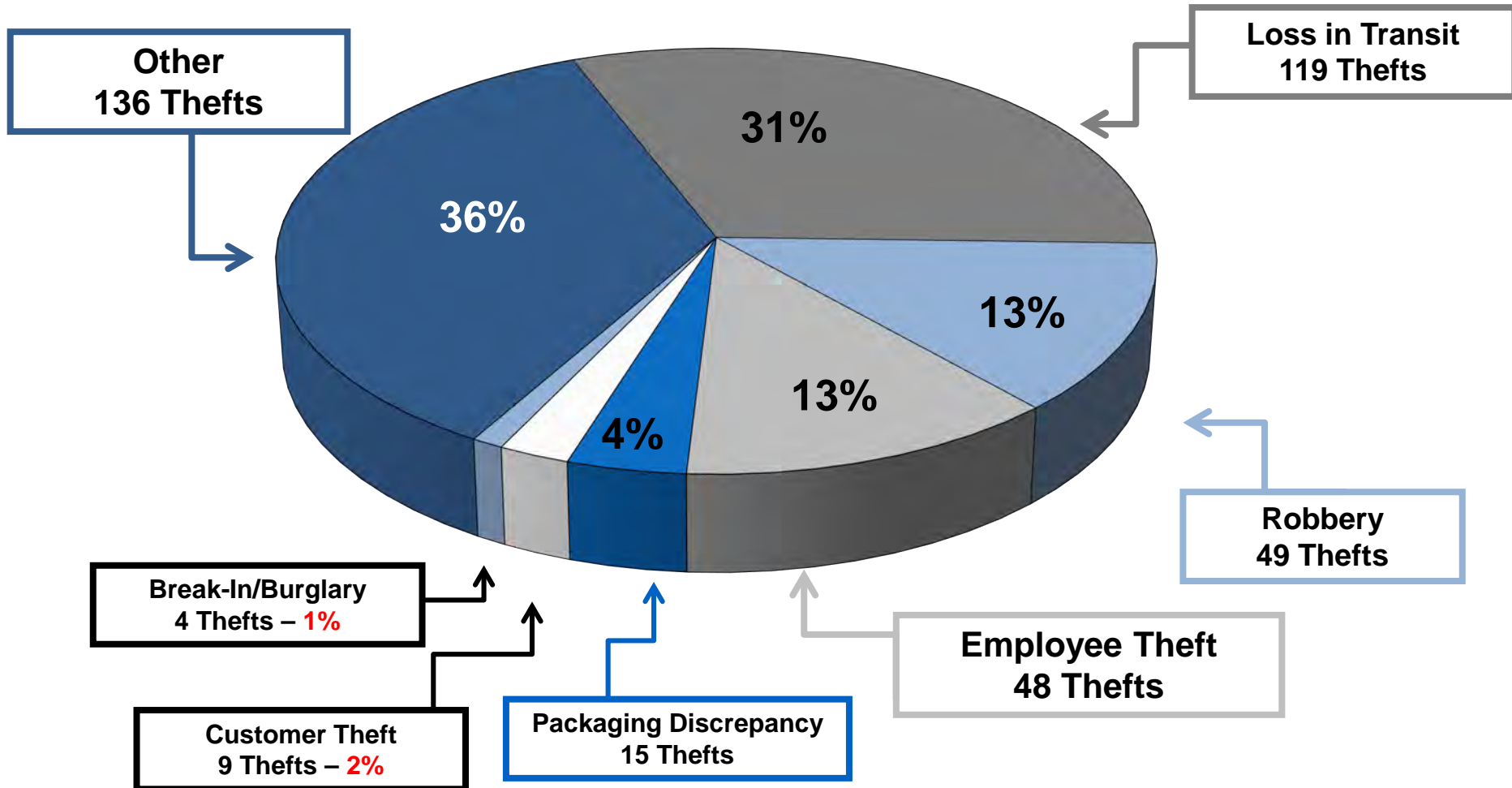

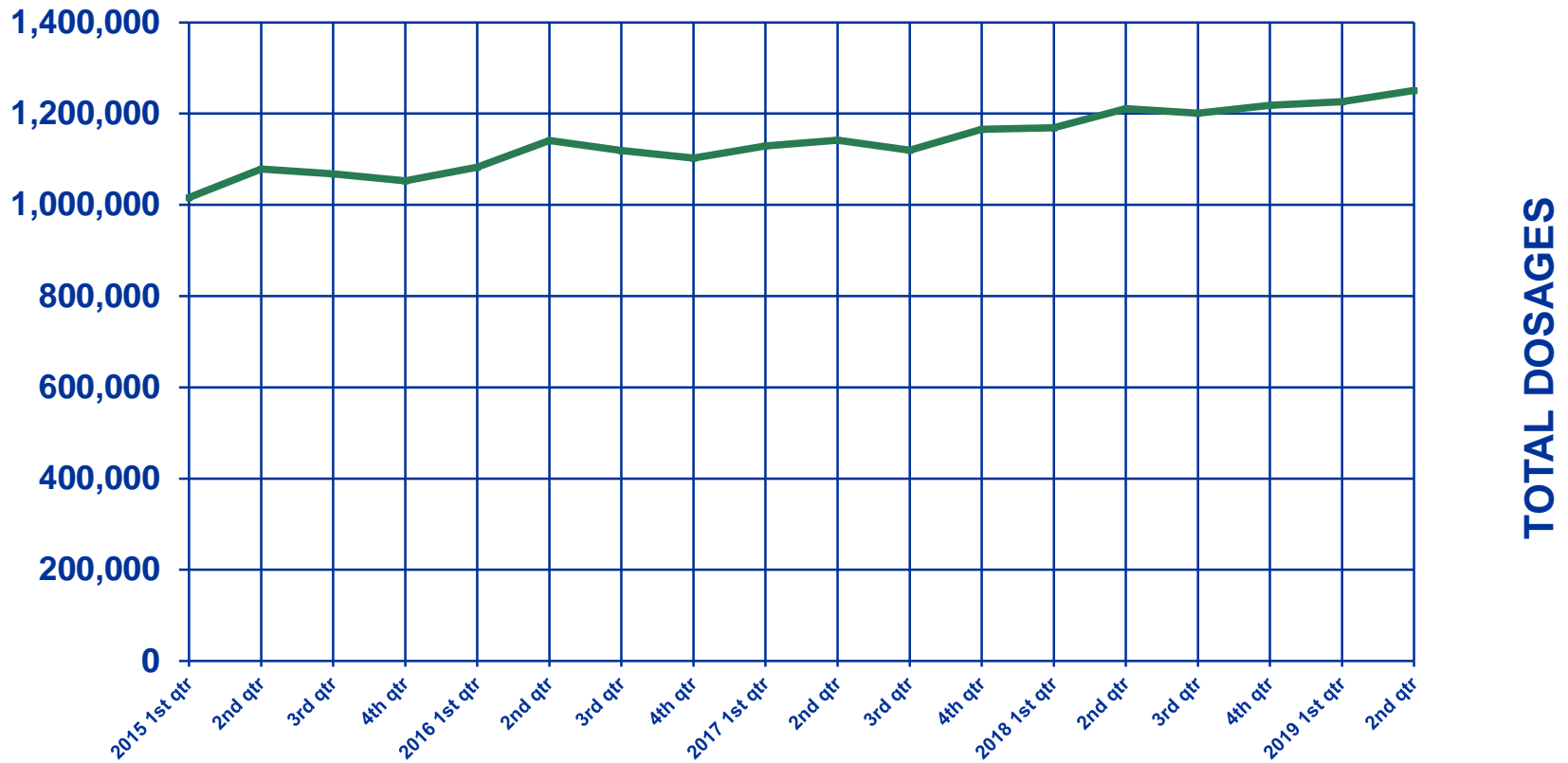
District of Columbia Hydrocodone Distribution January 1, 2015 – June 30, 2019



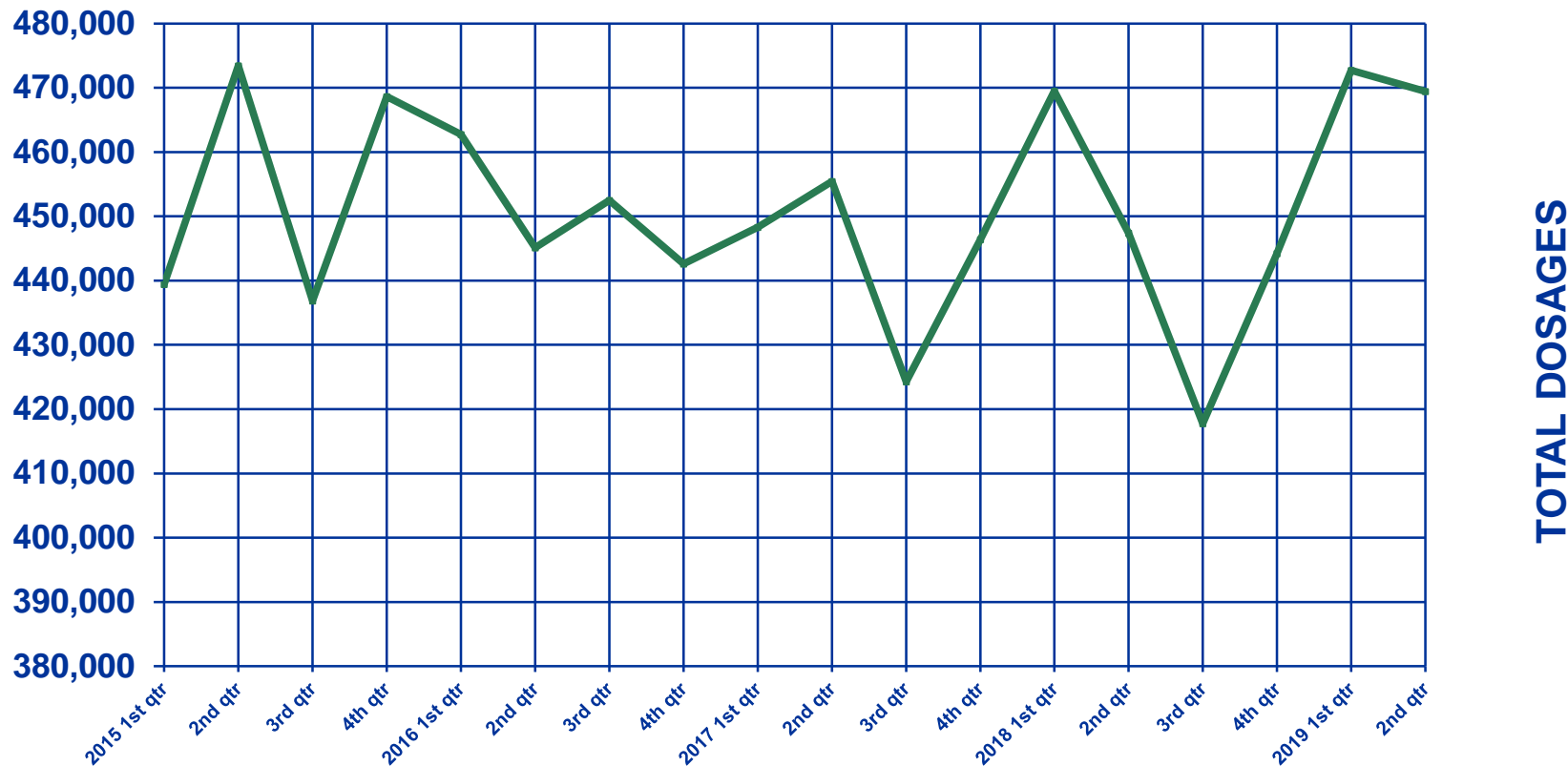
District of Columbia Oxycodone Distribution January 1, 2015 – June 30, 2019



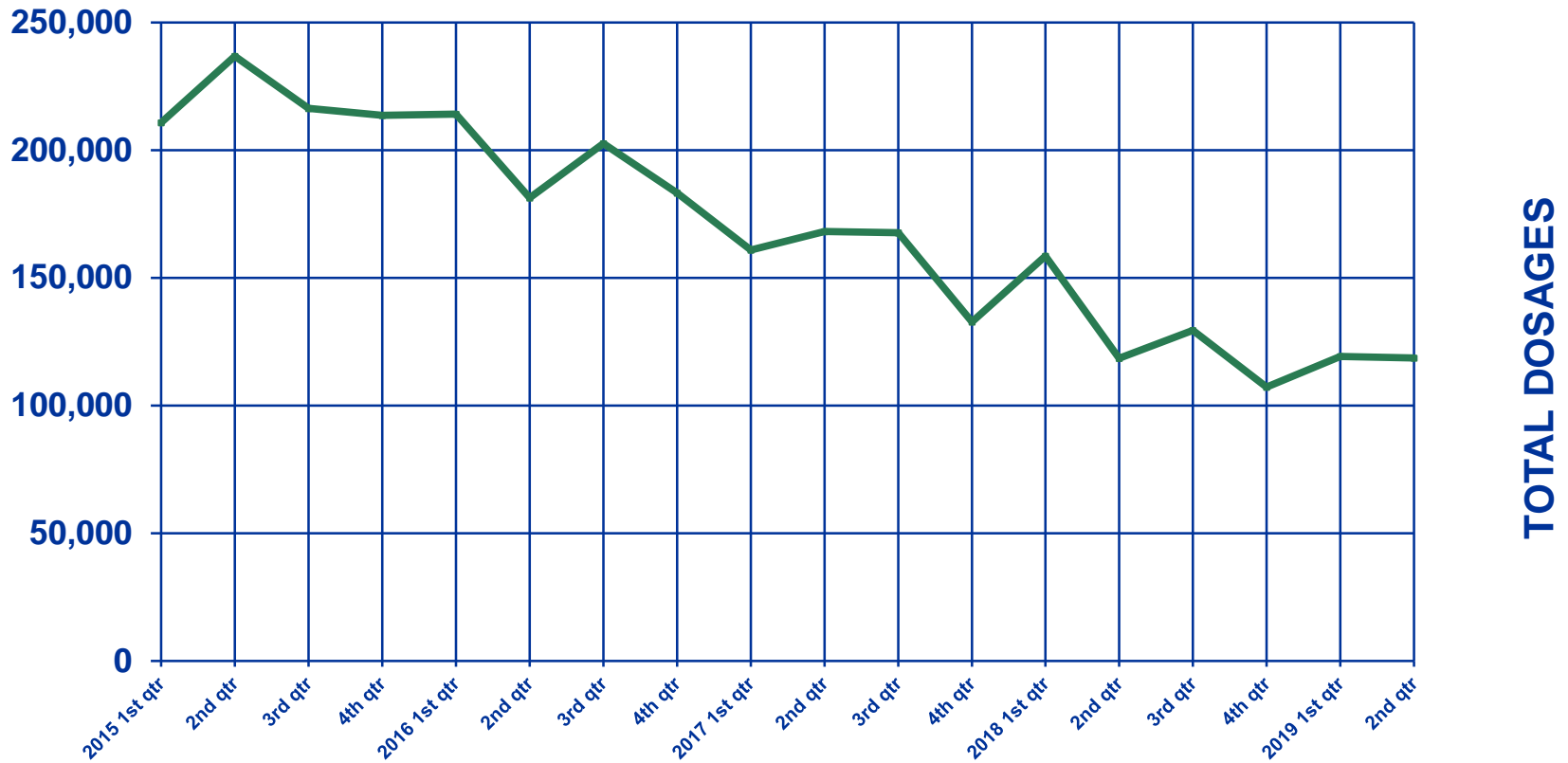
District of Columbia Amphetamines Distribution January 1, 2015 – June 30, 2019



District of Columbia Methylphenidate Distribution January 1, 2015 – June 30, 2019

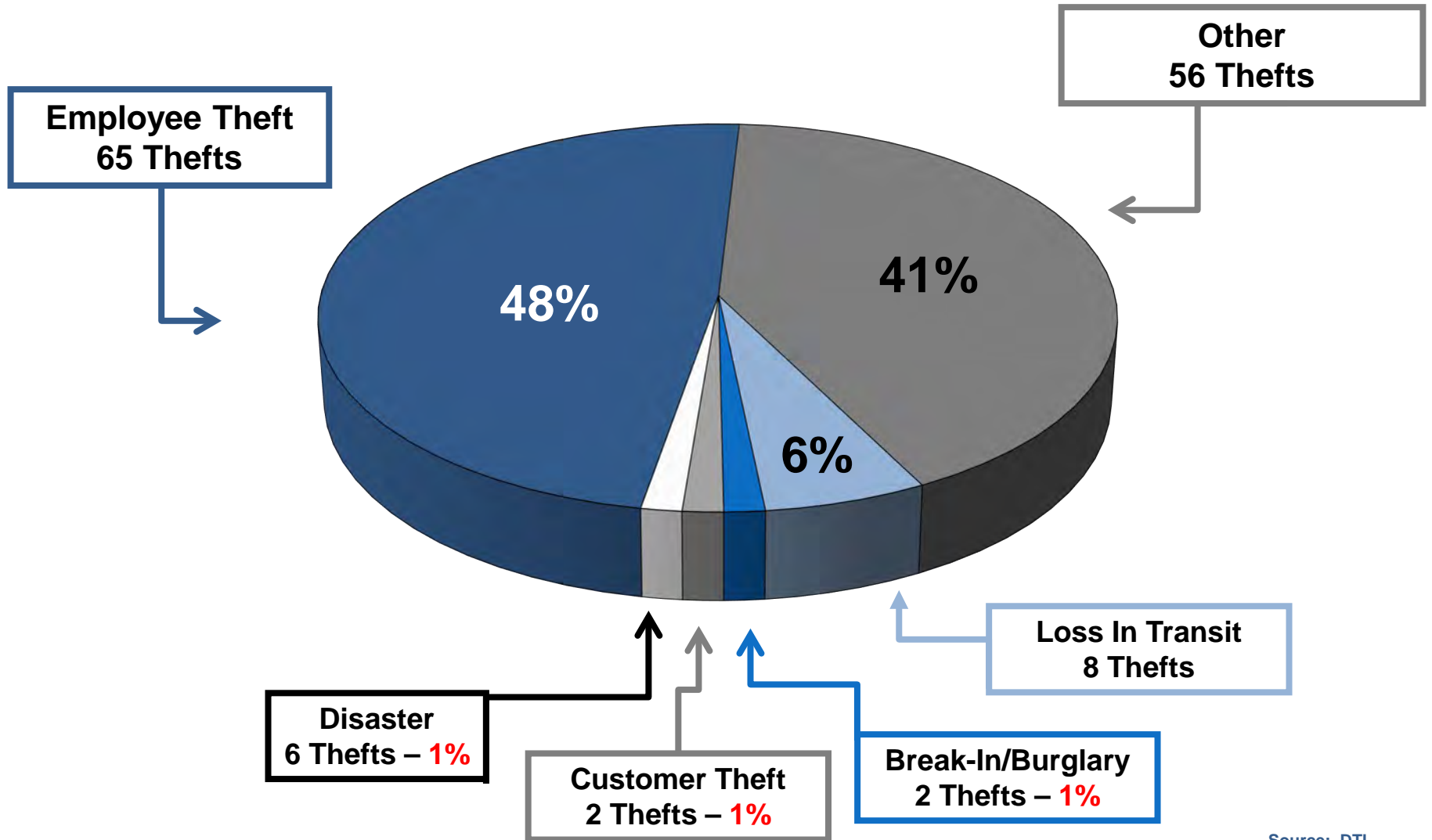


District of Columbia Morphine Distribution January 1, 2015 – June 30, 2019

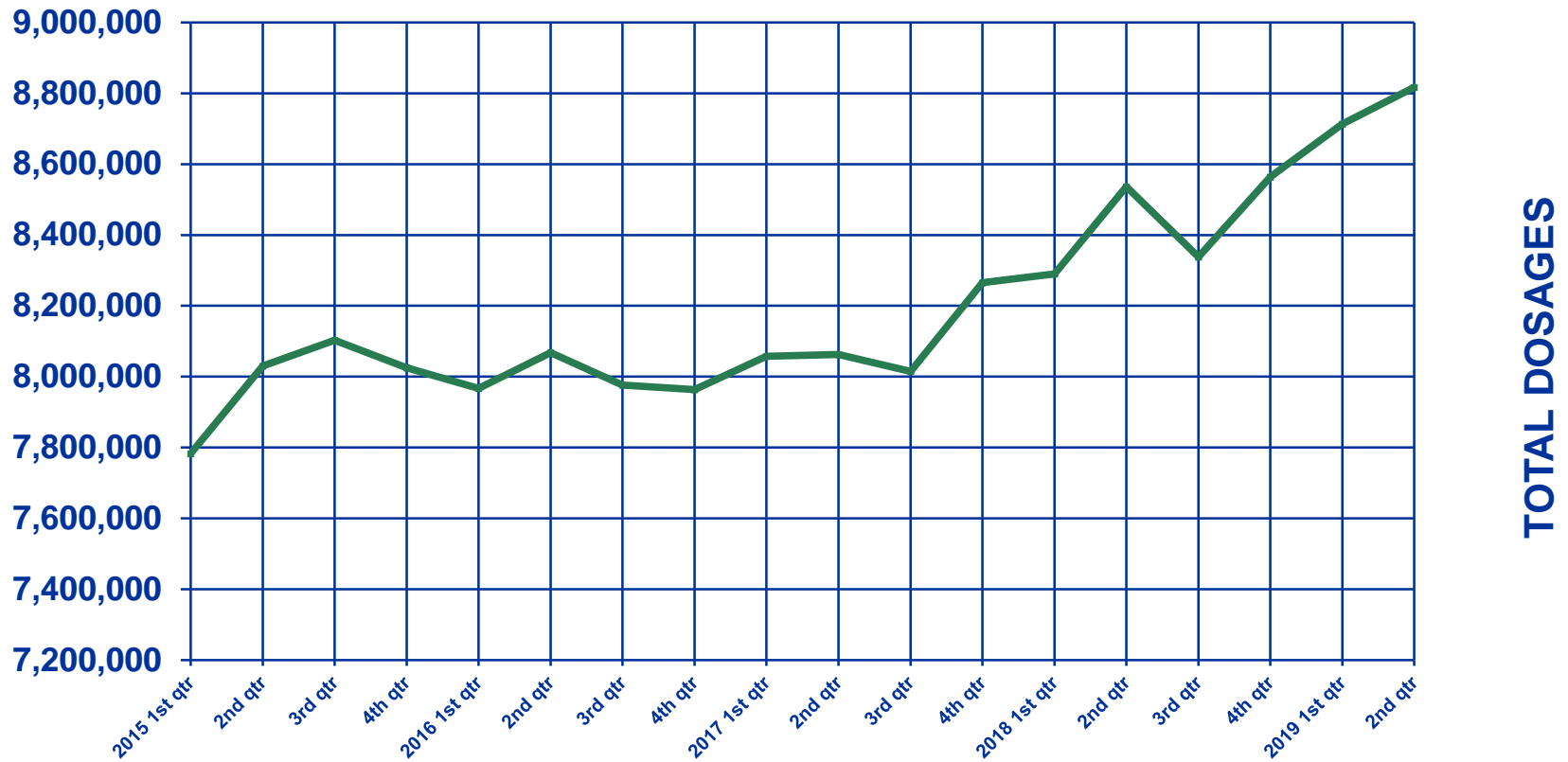
Maryland Hydrocodone Distribution January 1, 2015 – June 30, 2019



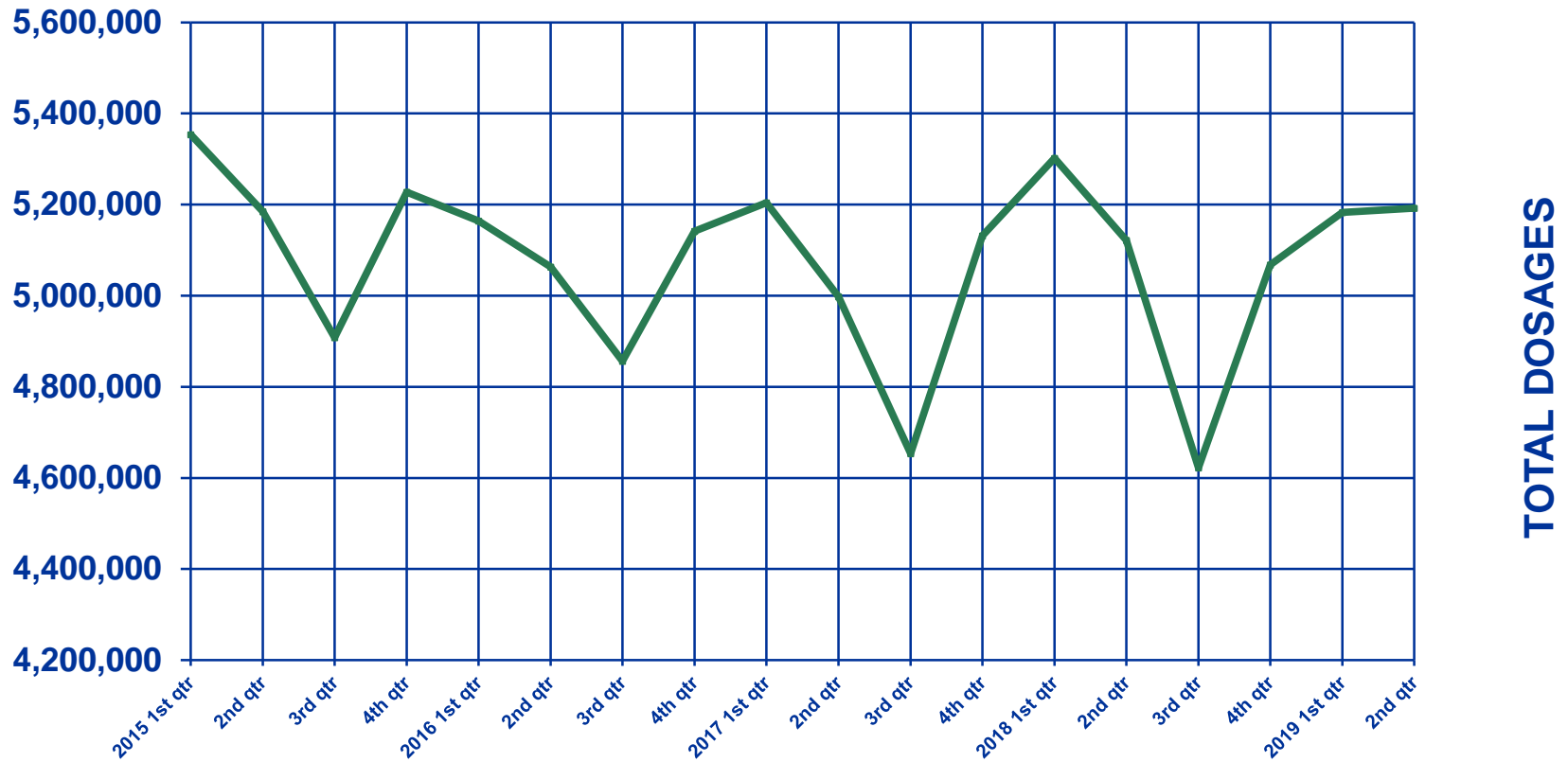
Maryland Oxycodone Distribution January 1, 2015 – June 30, 2019



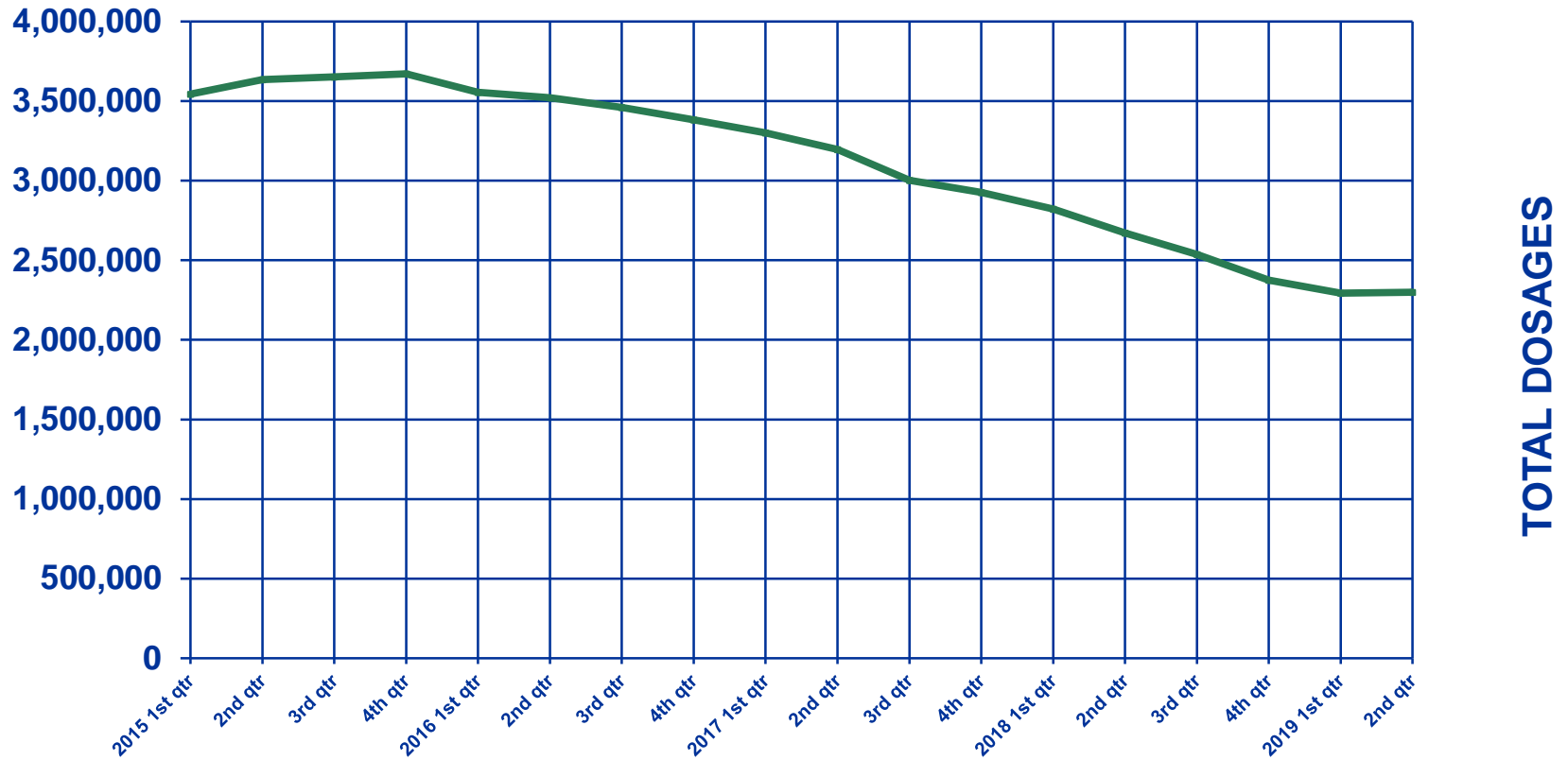
Maryland Amphetamines Distribution January 1, 2015 – June 30, 2019



Maryland Methylphenidate Distribution January 1, 2015 – June 30, 2019

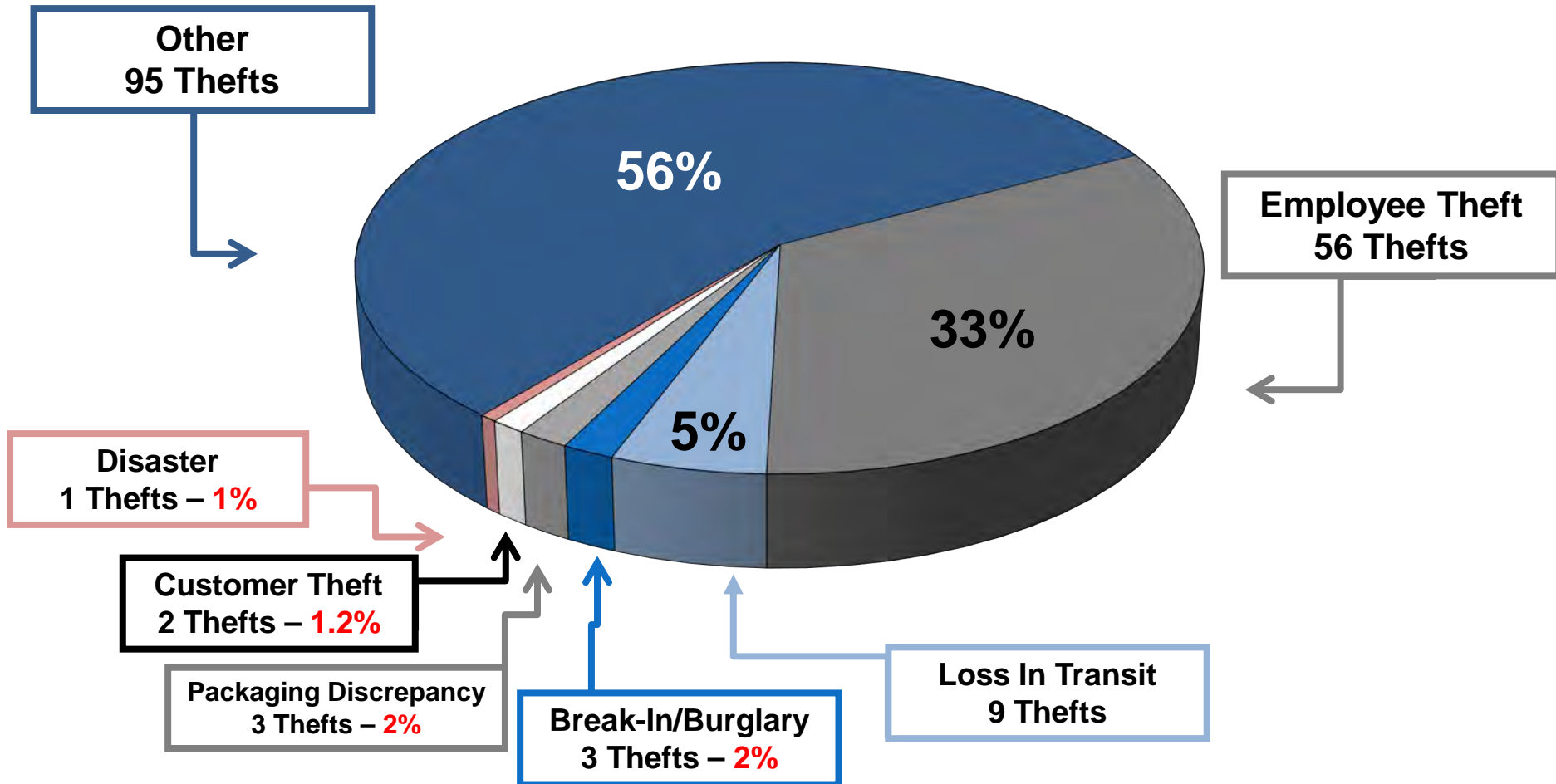


Maryland Morphine Distribution January 1, 2015 – June 30, 2019

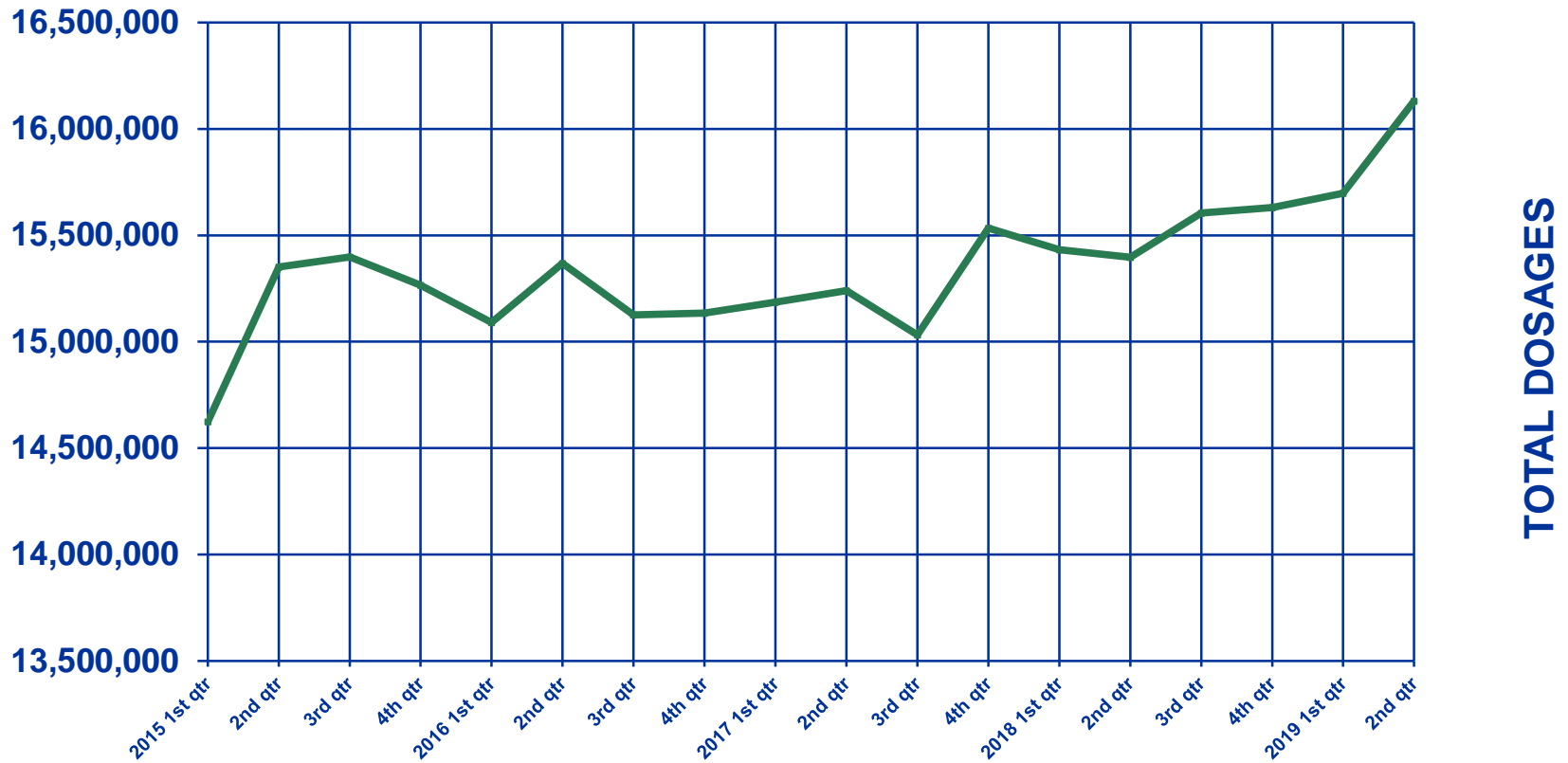
Virginia Hydrocodone Distribution January 1, 2015 – June 30, 2019



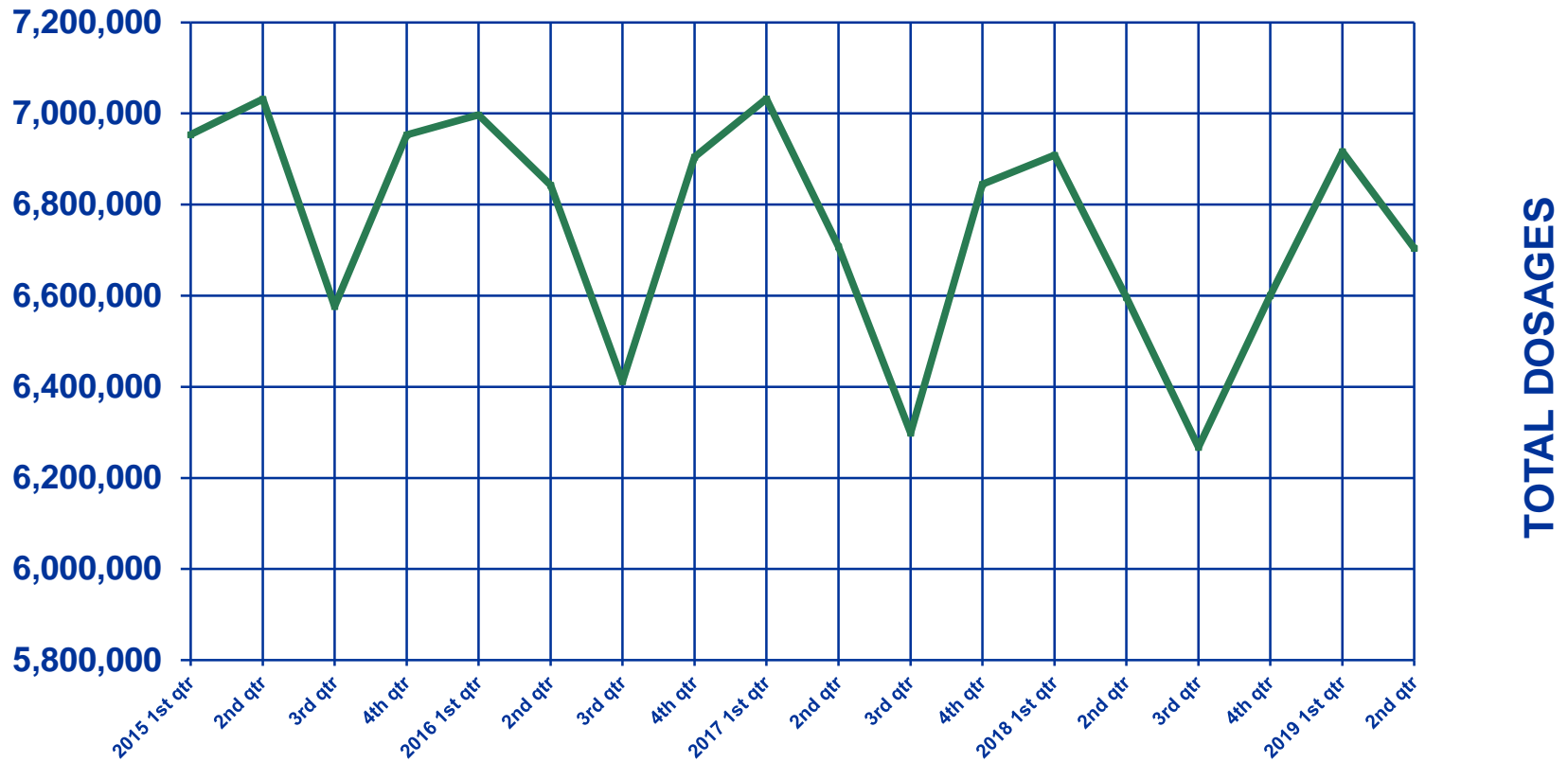
Virginia Oxycodone Distribution January 1, 2015 – June 30, 2019



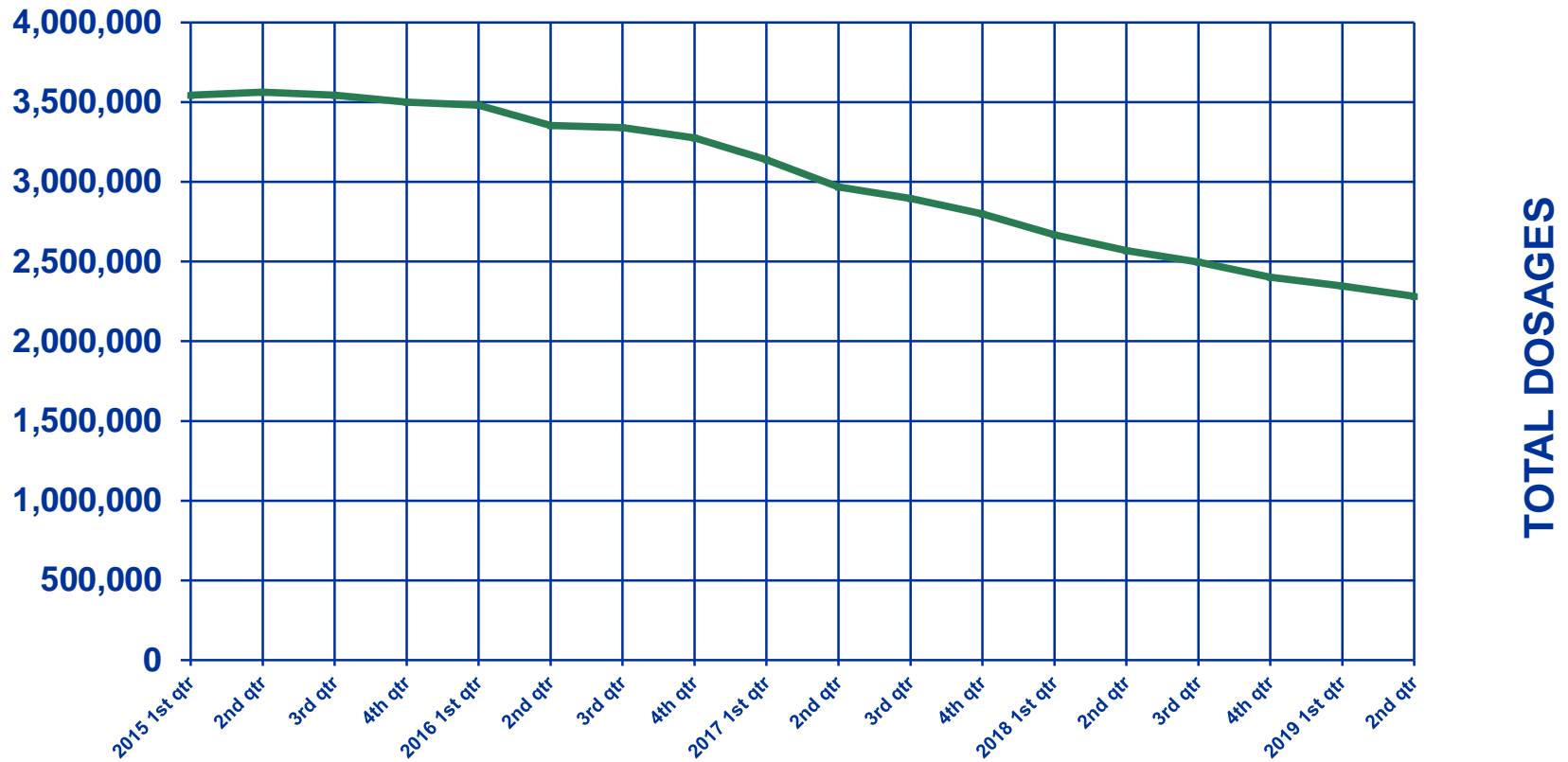
Virginia Amphetamines Distribution January 1, 2015 – June 30, 2019
