The Growing Problem

- Many states have seen a string of break-ins over the last few years.
- Most of this is focused on smaller, independent pharmacies often in small towns or rural areas.
- There appear to be organized groups that utilize social media and tools such as Google map street view to explore possible targets and surrounding security concerns for this purpose.



Pharmacy Thefts Reported

- 2023 Total Pharmacy Thefts:
 - 881 Total Events
 - 762 Burglaries
 - 119 Robberies
- 2023 DU Quantity Loss for All Pharmacies:
 - 3,016,187 due to Burglaries
 - 345,837 due to Robberies
- 2023 Dollar Value Losses for Pharmacies: (Dollar amounts are reported in AWP, Average Wholesale Price, cost to registrant, which reflects the actual loss to the registrant.)
 - \$8,487,131 Burglaries
 - \$2,041,583 Robberies



Possible Issues

Many smaller pharmacies meet minimum security criteria which is simply a secured space. They:

- do not have alarm systems
- do not have motion detection
- do not have cameras

 They often do have pictures on social media or websites that show pharmacy layout and possible security measures clearly.



Loss Prevention Tools

- Visible camera systems
 - Include behind counter surveillance so you can see what
 is going on in the prescription area
- Alarm systems
 - Silent alarm is a useful option
 - Motion detection down to the floor especially behind counters and in bays so that signal isn't being blocked
- Safe/Locked Cabinets
 - Sensors inside the safe for vibration or opening



Working Together

- Keep a record of drug losses reported to the DEA to include ATTEMPTED BREAK-INs as well.
- Share information with DEA Diversion Group for your area.
- Look for patterns
 - Several break-ins in a weekend have been seen to involve a single group hitting multiple stores
 - Tools used to break in?
 - Glass breaker, specific crowbars...

 - Alarm response time?
 - 43 Seconds smash and grab 4 bottles of prometh/codeine
